

**CITY OF PLYMOUTH
Ordinance No. 30 of 2009**

An Ordinance Establishing the Salaries of Elected and Appointed Officers, Administrative and other Wages of Employees of the City of Plymouth, for the Year commencing January 1, 2010, except as otherwise specifically indicated.

THE COMMON COUNCIL OF THE CITY OF PLYMOUTH DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Salaries for the following officers who may be elected at the next succeeding election, or who are appointed, are hereby established as indicated, commencing May 1, 2010.

The City Attorney shall be compensated in addition to the salary above set forth for services rendered in commencing, prosecuting, defending or appearing in legal actions and hearings in which the City may be a party in any Court or before any Board, Commission, or Administrative Body exclusive of ordinance violation prosecutions at the at the rate of \$80.00 per hour.

SECTION 4: Officers and employees shall be paid on a bi-weekly basis commencing with January 08, 2010, and every two weeks thereafter.

SECTION 5: Full-time employees shall be entitled to the following holidays with no loss of pay:

SECTION 6: Full-time employees shall have additional benefits as listed in the Benefit Appendix Schedule on file in the Office of the City Clerk.

SECTION 7: All officers and employees entitled to paid vacation hereunder are required to exhaust earned vacation time during the current calendar year. Vacation time may not be carried forward nor compensation paid for unused vacation except by action of the Common Council.

SECTION 8: The following provisions shall apply to the positions indicated:

Police Chief & Deputy: Uniform Allowance, Jury Duty and Witness Service shall be in accordance with such benefits currently in effect for members of the Plymouth Police Department.

Police Chief, Deputy Police Chief, Director of Public Works and Fire Chief: Use of a city vehicle to take home, however, subject to following IRS regulations.

Street Superintendent: Clothing Allowance, in accordance with such benefits currently in for members of the Plymouth Street Department.

SECTION 9: All Ordinances or Resolutions in contravention herewith are hereby repealed.

SECTION 10: This Ordinance shall be in full force and effect from and after its passage and publication as provided by law, commencing January 1, 2010.
