  - A. No. 3 An Ordinance Annexing and Rezoning Territory from the Town of Plymouth to the City of Plymouth Pursuant to Wis. Stat. 66.0217 (2) Portion of parcel no. 59016-222890, lying west of 1446 Pilgrim Road: Tim Blakeslee explained Inkworks currently operates its business on 1446 Pilgrim Rd. Inkworks is looking to expand their business by adding on to their existing building. They are looking for one acre of land directly west of their current facility to be annexed into the City of Plymouth. In addition to the request for annexation this area will be brought into the City with Heavy Industrial (HI) zoning designation. Mayor Pohlman declared the public hearing open at 7:04 PM regarding Resolution No. 3. There being no public comments the Mayor called the Public Hearing closed.
