 - A. Approval of ATC Plymouth Abandon Design Agreement Tim Blakeslee, City Administrator/Utilities Manager explained that ANR Pipeline is a current customer of Plymouth Utilities. ANR is in the process of expanding its natural gas Kewaskum Compressor Station. In July 2023, the Common Council approved a Project Reimbursement Agreement with ANR in which ANR agreed to reimburse Plymouth for costs incurred by American Transmission Company (ATC) to help accelerate project completion. In order for ATC to expedite the project and meet the timeline requested by ANR, ATC must complete design engineering and commence land acquisition activities for both proposed transmission line routes to the new substation location in the Town of Mitchell prior to PSC selection of the transmission line route. Only one route will be selected by the PSC, leading to the abandonment of associated engineering and land acquisition work for the alternative route. Motion was made by Nelson/Matzdorf to approve the ATC – Plymouth Abandon Design Agreement subject to final attorney/staff

concurrence and approval of agreement language and the finalization of a side letter/MOU with ANR. Upon the call of the roll, all voted aye. Motion carried.


- **B.** Approval of Pedestrian Crossing Rapid Flashing Beacon Signs- Director of Public Works Austin explained as part of the 2024 Capital Improvement Plan \$15,000 was allocated to purchase and install one set of solar powered, push button activated, Rapid Flashing Beacon (RFB) Pedestrian Crossing Signs as a pilot program. In December the Public Safety Committee met to discuss the pedestrian/car crash that occurred on November 14, 2023 at the intersection of Eastern Ave and South St. The committee recommended that Common Council approve two sets of RFB's. One set to be installed on Eastern Ave at South St. and the other on Eastern Ave. at N Bruns Ave. Motion was made by Tauscheck/Gilson to approve the purchase of Rapid Flashing Beacons from TOPCO in the amount of \$22,543.20 for the two crossings as identified by the Public Safety Committee and allow up to \$15,000 to be used out of the contingency for this project. Upon the call of the roll, all voted aye. Motion carried.



December 2023 Electric Sales





December 2023 Electric Revenue



Overall sales are down from 2022 as a result of reduced PCAC rates. In turn, Purchase Power expense is down.


December 2023 Water Revenue

RE: Public Hearing and Discussion on Mill Pond Dam

Background: In 2015, the City of Plymouth received a notice from the Wisconsin Department of Natural Resources (WDNR) that required the spillway capacity of the Mill Pond Dam to be brought into compliance with NR333.06 within 10 years (2025). As part of the 2023 Budget, the City included funding to hire an engineering firm to provide services to assist the City in making the decision on whether to remove the dam completely or make necessary upgrades/replace the dam to meet DNR regulations.

The City issued a Request for Qualifications (RFQ) in early 2023 and received proposals from Kapur & Associates and Ayres Associates. In March 2023, Ayres Associates was selected to complete a study providing options available. Ayres has significant experience in both dam removal and dam upgrade/replacement. In addition, The City of Plymouth was also allocated \$1,000,000 in the 24-25 State Budget for the removal or restoration of the dam. Ayres has reviewed the options and completed the Mullet River Dam Spillway Improvement and Dam Removal Feasibility Study. Ayres presented the study and the four various dam removal and replacement options on October 28, 2023. At the Committee of the Whole meeting on the November 28, 2023, the majority consensus was to move forward with a Public Open House followed by a Formal Public Hearing to provide the community an opportunity to learn more about the project and provide feedback. The Public Open House will be conducted immediately prior to the Common Council meeting on January 30, 2024 (from 5:30 p.m. to 6:30 p.m.).

Public comments are currently being received via an online survey to solicit feedback from residents. In addition, comments from the Public Open House will be added to the survey results as appropriate. These comments will be compiled for Common Council review.

The formal Public Hearing tonight is intended as an opportunity for members of the public to speak "on the record" prior to a Common Council decision on the Dam. The Common Council is currently scheduled to make a decision to remove or replace the dam on February 13, 2024. If the decision is to replace the dam, the Common Council will also need to decide which of the three options is selected.

The public hearing is also noticed for Common Council discussion. Following the Public Hearing, Council members may provide additional feedback if desired about the project and process. No formal action will be taken tonight.

Recommendation: Hold a Public Hearing regarding Mill Pond Dam Project and discuss as needed.

Background:

ANR Pipeline Company (ANR) is a current customer of Plymouth Utilities. ANR is in the process of expanding its natural gas Kewaskum Compressor Station ("KCS") situated just north of Beechwood, WI. This expansion involves the installation of two 4,160-volt 3,750-hp motors, anticipating an increase in ANR's peak load requirements at KCS to approximately 7,385 kW. Moreover, the electric distribution equipment in the southwestern part of the Plymouth Utilities service territory has approached near capacity in recent years. In response to the growing demand and to enhance the overall reliability of service for all customers, Plymouth Utilities has committed to constructing a new substation by the end of 2025. This commitment is formalized through a Substation Agreement with ANR, entered into in December 2022.

In July 2023, the Common Council approved a Project Reimbursement Agreement with ANR in which ANR agreed to reimburse Plymouth for costs incurred by American Transmission Company (ATC) to help accelerate project completion or in the event of project cancellation. At the meeting on January 9, 2024 the Common Council approved the ATC - Plymouth Abandon Design Agreement' (contingent on final attorney/staff concurrence and approval of agreement language and the finalization of a side letter/MOU with ANR). This agreement was needed in order for ATC to expedite the project and meet the timeline requested by ANR.

Over the past several weeks during discussions between the Utility and ANR regarding the finalization of a side letter/MOU it was determined that requested conditions and funding amount involved for project acceleration would be better suited to a new agreement approved by the Common Council rather than a simple side letter/MOU.

Our attorney with Boardman Clark is currently finalizing the Pre-Construction Elective Services Reimbursement Agreement with ANR. The most current draft is attached for review. Staff requests Common Council approval of the Pre-Construction Elective Services Reimbursement Agreement upon final attorney/staff concurrence and approval of agreement language.

Recommendation: Staff recommends approval of Approval of ANR – Plymouth Pre-Construction Elective Services Reimbursement Agreement subject to final attorney/staff concurrence and approval of agreement language.

PRE-CONSTRUCTION ELECTIVE SERVICES REIMBURSEMENT AGREEMENT

WHEREAS, Plymouth and ANR are parties to a Substation Agreement pertaining to the Plymouth #5 project ("Substation Project") dated December 27th, 2022 ("Substation Agreement");

WHEREAS, Plymouth is party to a Distribution-Transmission Interconnection Agreement with the American Transmission Company LLC ("ATCLLC"), which is a public utility and transmission company established under Wisconsin law;

WHEREAS, Plymouth is required to enter into a Pre-Construction Elective Services Agreement ("ESA") with ATCLLC in order to permit ATCLLC to undertake certain preconstruction engineering design and land acquisition activities in advance of the timeline normally required during the process of obtaining a certificate of public convenience and necessity and thereby accelerate the anticipated in-service date of the transmission facilities that will be interconnected to the Substation Project;

WHEREAS, Plymouth will be required to reimburse ATCLLC for approximately \$1.2 million in costs under the ESA as described further below, which such costs are not included in the contribution in aid of construction provided for by the Substation Agreement;

WHEREAS, the potential need for such costs was acknowledged by the Parties in paragraph 8 of the Project Reimbursement Agreement, dated July 20, 2023;

WHEREAS, the Parties agree that it is appropriate to provide a mechanism whereby ANR will reimburse Plymouth for ESA-related costs by entering into this Agreement;

NOW THEREFORE, in consideration of the above premises, and mutual covenants and agreements herein contained, the Parties hereby agree as follows:

AGREEMENT

- 1. <u>Recitals</u>. The foregoing recitals are hereby incorporated into this Agreement.
- 2. <u>Reimbursement Obligation</u>. ANR agrees to reimburse Plymouth for the following costs incurred or irrevocably committed by ATCLLC under the ESA. The reimbursement obligation set forth in this Section 2 shall not exceed the estimated costs set forth in the table below.

Activity	Est. Cost
Design Engineering Work	\$418,598
Land Acquisition Work	\$799,532
Environmental Work	\$28,696
Total Elective Pre-Construction Services Cost:	\$1,246,826

Any increase in the reimbursement obligation of ANR beyond what is described in the table above shall require ANR's prior consent, such consent not to be unreasonably withheld.

- 3. <u>Payment of the Reimbursement Obligation</u>. Payment of the Reimbursement Obligation shall be made by ANR to Plymouth by wire transfer within thirty (30) days following receipt of an invoice showing the amount required to be reimbursed for the Work performed by ATCLLC under the ESA. The Parties understand and acknowledge that Plymouth has a right to dispute the amount of the payment required by ATCLLC under the ESA and shall confer about the merits of exercising that right. If any payment amount is successfully disputed by Plymouth, the amount shall be returned to ANR by Plymouth.
- 4. <u>Termination of ESA</u>. Upon five (5) days' prior written notice from ANR, Plymouth shall terminate the ESA pursuant to its right to terminate the ESA for its convenience.
- 5. <u>Further Assurances</u>. Both Parties reaffirm their respective obligations to do all such further acts and execute and deliver all such documents as may be required by ATCLLC, acting reasonably, to effectuate the Substation Project.
- 6. <u>Assignment</u>. Neither this Agreement, nor any of the rights, interests or obligations in this Agreement, may be assigned or delegated, in whole or in part, by operation of law or otherwise, by either ANR or Plymouth, without the prior written consent of the other Party, which consent shall not be unreasonably withheld. This Agreement shall be binding upon the successors and assigns of the respective Parties hereto.
- 7. <u>Governing Law</u>. This Agreement shall be governed by and construed according to the laws of the State of Wisconsin without regard to conflict of laws principles.
- 8. <u>Attorneys Fees</u>. Each Party shall bear its own costs and expenses with regard to this Agreement and any other agreement entered into in connection with this Agreement; provided, however, that in the event of a dispute between the Parties, if a Party is successful in an action to enforce its rights hereunder, the other Party shall reimburse the prevailing Party for its costs and expenses associated with that dispute, including reasonable attorneys' fees.
- 9. Entire Agreement; no Impact on Substation Agreement. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof. It is not intended to modify or amend the Substation Agreement in any way. This Agreement may be modified or amended only by an instrument in writing signed by the Parties hereto. Plymouth further agrees that it will not amend or modify the ESA without prior written consent of ANR.
- 10. <u>Miscellaneous</u>. This Agreement may be executed in a number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.

Re: Changes to Open Burn Ordinance

The ordinance change being presented to you for the council meeting on 1-30-2024 consists of the following:

- (b) Residential Fire Pit Construction. Residential recreational bonfire or fire pit areas may be constructed and used with the following conditions and subject to the permit requirement of subsection (d):
- (2) Ceremonial Non-residential campfire or bonfires;

Theses changes are being presented to the common council for a few reasons.

- 1. In research and talks with surrounding communities, Plymouth is the only community in the area that requires a fire pit permit for residential fire pits. It is difficult to impossible to confirm this permit is being pulled for all residential fire pits.
- 2. The ordinance change is only to remove the annual permit for residential fire permits. Residential fires must still meet safe distance and placement requirements. Any other types of burning would still need a permit and approval.

Ordinance No. _____ of 2024

AN ORDINANCE AMENDING SECTION 5-2-9 OF THE MUNICIPAL CODE OF THE CITY OF PLYMOUTH, WISCONSIN REGARDING OPEN BURNING

WHEREAS, upon recommendation of the fire chief, the Common Council of the City of Plymouth finds it best serves the public interest to allow residential recreational fires without a permit when such fires are contained within fire pits constructed and used in conformity with City Code Section 5-2-9.

NOW, THEREFORE, the Common Council of the City of Plymouth, Wisconsin, does hereby ordain as follows:

Section 1. <u>Amending Code</u>. Section 5-2-9, Open Burning, of the City of Plymouth Code is hereby amended to read as follows (deletions shown by strikethrough, additions by <u>underscore</u>):

"SEC. 5-2-9 OPEN BURNING.

(a) **Open Burning Prohibited**. No person, firm or corporation shall build any outdoor fire within the corporate limits of the City of Plymouth, except as set forth in Subsections (b) or (c) of this Section or as permitted under Subsection (d). Fire disposal of rubbish, trash, or combustible waste is prohibited.

(b) **Residential Fire Pit Construction.** Residential recreational bonfire or fire pit areas may be constructed <u>and used</u> with the following conditions and subject to the permit requirement of subsection (d):

(1) Permanent fire pits shall not be constructed within ten (10) feet of a structure or combustible material, unless otherwise approved by the Fire Chief.

(2) Permanent fire pits shall be no larger than forty (40) inches in diameter.

(c) **Exceptions.** Outdoor cooking over a non-wood burning fire fueled by charcoal or propane gas contained in a device or structure designed for such use, provided such fire is constantly attended by a competent person until extinguished.

(d) **Permit Required**. The following fires are subject to a permit granted by the Fire Chief:

(1) Controlled burning of grass or similar vegetation for environmental management purposes;

(2) CeremonialNon-residential campfire or bonfires;

(3) Other occasions of desirable outdoor burning not specified by this Subsection but not as an alternative to refuse removal or disposal of which other methods are available may be granted single occasion approval.

(4) The permit shall be granted only after an on-site inspection, consideration of any hazards that could affect adjacent property and observance of any safety restrictions that the Fire Chief may require. All open or recreational fires must be constantly maintained by a competent person until extinguished. A fee of Five Dollars (\$5.00) shall be paid to the City of Plymouth for each permit issued.

(e) **Chief May Prohibit**. The Fire Chief is permitted to prohibit any or all bonfires and outdoor rubbish fires when atmospheric conditions or local circumstances make such fires hazardous except on written permit from the Fire Chief or any fire warden for said City, which permit shall designate the time and place for such burning. Notice of designation of a fire danger emergency period shall be made by publication of an appropriate order, once in the official newspaper, to be effective forthwith.

(f) **Burning on Streets**. No materials may be burned upon any street, curb, gutter, or sidewalk.

(g) **Liability**. Persons utilizing and maintaining an outdoor fire shall be responsible for any liability resulting from damage caused by the fire.

(h) **Airborne Open Flame Devices Prohibited**. No airborne open flame device may be launched or used, free-floating or tethered, in the City. Airborne open flame devices from neighboring jurisdictions that enter into the City are also prohibited. The term "airborne open flame device" means any airborne device typically constructed from paper with a wood frame containing a candle or fuel cell composed of a waxy flammable material or other open flame which serves as a heat source to heat the air inside the lantern to cause it to lift into the air. "Airborne open flame device" includes, but is not limited to, sky lanterns, sky candles, fire balloons, and airborne paper lanterns excluding manned hot air balloons."

Section 2. <u>Severability</u>. Should any portion of this Ordinance or the affected Municipal Code Section be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder shall not be affected.

Section 3. <u>Effective Date</u>. This Ordinance shall take effect the day after publication or posting.
