Owner Tom Schultz was present. Schultz stated [they] had purchased a 64 acre parcel. Two parcels were created at 5 acres each. The homestead, and an additional 5 acres. The balance would remain as farmland. This division is about 1 mile east of STH 57 on Sumac Road. Member Hildebrand made the motion to approve, with a second by Nicolaus. - 3.) Sign placement seeking approval: Per Sec 13-1-106(j) A sign identifying a planned shopping center grouping may be permitted with the approval of the plan commission, and the commission may, in such case, modify the regulations applicable to the height, size, and location of such sign consistent with the spirit and intent of the regulations. 2133 Eastern Ave., Fairfield Plaza. Lance McTrusty and Paul Butler from Bauer Sign, and Condo Association President Mike Schields were present. Paul Butler explained the situation and design to the Plan Commission members. Starting several years ago, permission was granted to move the Fairfield Plaza sign due to it's location interfering with the O'Reilly Auto build. The O'Reilly Auto site was subsequently parceled off, thus creating a non-conformance with a sign greater than 200 square feet per side, which was about how large the old Fairfield Plaza tenant sign was. A sign permit was issued for a smaller design that would have conformed to the smaller allowed sign square footage allowed for smaller parcels. Bauer sign had apparently reconstructed a larger sign, as initially intended. With the sign square footage being in the excess of what the Ordinance allowed, verified by the City Attorney, per Sec 13-1-106(j) allows the Plan Commission to approve a sign larger than allowed for a planned shopping mall. Member Schellin asked about the sign being built as being actually larger, as well questioning the smaller sign. Pond Dam

Background: In 2015, the City of Plymouth received a notice from the Wisconsin Department of Natural Resources (WDNR) that required the spillway capacity of the Mill Pond Dam to be brought into compliance with NR333.06 within 10 years (2025). As part of the 2023 Budget, the City included funding to hire an engineering firm to provide services to assist the City in making the decision on whether to remove the dam completely or make necessary upgrades/replace the dam to meet DNR regulations.

The City issued a Request for Qualifications (RFQ) in early 2023 and received proposals from Kapur & Associates and Ayres Associates. In March 2023, Ayres Associates was selected to complete a study providing options available. Ayres has significant experience in both dam removal and dam upgrade/replacement. In addition, The City of Plymouth was also allocated \$1,000,000 in the 24-25 State Budget for the removal or restoration of the dam. Ayres has reviewed the options and completed the Mullet River Dam Spillway Improvement and Dam Removal Feasibility Study. Ayres presented the study and the four various dam removal and replacement options on October 28, 2023. A Public Open House and Public Hearing were conducted on January 30, 2024 to provide the community an opportunity to learn more about the project and provide feedback. Public comments were also received via an online survey and are attached for review.

Resolution Information:

A decision for Common Council to decide whether to replace or remove the Mill Pond Dam is the first of three items related to the dam on the agenda for consideration. Attached for review is Resolution No. 2024-1, which directs the replacement of the Mill Pond Dam. If the Council opts to remove the dam, the resolution language can be adjusted accordingly. Resolution No. 1 accomplishes the following:

- Expresses the Common Council's intention to replace the Mill Pond Dam.
- Empowers the City Administrator/Utilities Manager to seek and accept grants available for the project.
- Authorizes the City Administrator/Utilities Manager to incorporate the Mill Pond Dam project into the 2025 borrowing for any expenses beyond those covered by grants and/or the capital improvement fund.
- Instructs Staff to take all necessary steps to advance the project with the chosen dam option (discussed during item 7A).
- Grants the City Administrator/Utilities Manager the authority to request an extension of the timeline from the Department of Natural Resources (DNR) if necessary.

RESOLUTION NO. 2024 - 1

A Resolution of the City of Plymouth Common Council Approving the Replacement of the Mill Pond Dam

WHEREAS, in 2015 a notice was issued from the Wisconsin Department of Natural Resources (WDNR) that required the spillway capacity of the Mill Pond Dam to be brought into compliance with Wis. Admin. Code NR § 333.06 within 10 years (2025); and

WHEREAS, as part of the 2023 Budget, the City included funding to hire an engineering firm to provide services to assist the City in making the decision on whether to remove the dam completely or make necessary upgrades/replace the dam to meet DNR regulations; and

WHEREAS, in March 2023, Ayres Associates was selected to complete a study providing options available. In October 2023, Ayres presented the Mullet River Dam Spillway Improvement and Dam Removal Feasibility Study to the Common Council. In addition, the Common Council hosted an open house, public hearing, and online survey to gauge public opinion.

WHEREAS, furthermore, the City of Plymouth received allocation of \$1,000,000 in the State of Wisconsin 2023-25 Biennial Budget for the removal or restoration of the dam and the City of Plymouth must complete the Municipal Dam Grant application to receive the funding.

NOW, THEREFORE, **BE IT RESOLVED**, by the Common Council of the City of Plymouth, Sheboygan County, Wisconsin that:

- 1. <u>Decision Regarding Dam</u>: The City shall replace the Mill Pond Dam as required by the Department of Natural Resources (DNR) in accordance with NR § 333.06.
- 2. <u>Future Grants:</u> The City Administrator/Utilities Manager is hereby permitted to apply for and accept grants as available to reduce the fiscal impact of replacing the dam on the residents of Plymouth. This includes completing, signing and submitting, all materials and paperwork related to the State of Wisconsin Municipal Dam Grant and any other grant deemed appropriate.
- 3. Additional Costs: The City Administrator/Utilities Manager is hereby permitted to include the Mill Pond Dam project in the upcoming 2025 borrowing for any costs beyond those covered by grants and/or the capital improvement fund. If estimated project costs exceed the amount indicated in the Dam Spillway Improvement and Dam Removal Feasibility Study, the Common Council will be notified.
- 4. <u>Dam Replacement Option:</u> Following the selection of the Dam Replacement Option by the Common Council, the City Administrator/Utilities Manager, and at his direction other municipal staff, are directed to take all appropriate action to move the project forward with the selected option at a timely pace.
- 5. **Project Extensions:** The City Administrator/Utilities Manager has the authority to request a timeline extension from the DNR should it be required to meet the project schedule.

<u>Background:</u> The second of three dam related items on the agenda tonight is approval of Resolution No. 2024-2 Authorizing Participation in the Department of Natural Resources (DNR) in the Municipal Dam Grant Program. Although the City of Plymouth received allocation of \$1,000,000 in the State of Wisconsin 2023-25 Biennial Budget for the removal or restoration of the dam, the DNR is requesting the City of Plymouth follow the standard grant application process to have access to the funding. This resolution includes the following statements as required per the Municipal Dam Grant Program:

- Designates an authorized representative to apply for the grant and act on behalf of the applicant.
- Indicates a municipality's/lake district's commitment to the "local share" and agrees to pay a share
 of the eligible costs which are equal to the total project cost minus the state share.

WHEREAS, \$1,000,000 in the State of Wisconsin 2023-25 Biennial Budget was awarded to the City of Plymouth as a continuing appropriation from the general fund, to provide a grant to the City of Plymouth for removal or modification of the dam on Mill Pond.

WHEREAS, the state share for project costs exceeding the \$1,000,000 appropriation awarded to the City of Plymouth in the State of Wisconsin 2023-25 Biennial Budget, may not exceed 50 percent (50%) of the first \$1,000,000.00 of total eligible costs nor 25 percent (25%) of the next \$2,000,000.00 of total eligible project costs

NOW, THEREFORE, BE IT RESOLVED, that the City of Plymouth HEREBY AUTHORIZES the City Administrator/Utilities Manager to:

- Submit an application to the DNR for financial aid under ch. NR 335, Wis. Adm. Code;
- sign grant agreement documents;
- take all necessary action to complete the project associated with any grant agreement;
 and
- submit reimbursement claims along with necessary supporting documentation.

BE IT FURTHER RESOLVED THAT The City of Plymouth agrees to pay a share of the eligible costs which is equal to the total project cost minus the state share.

NOTE: Section 31.01(4), Wis. Stats., defines a municipality as any town, village, city, or county. Section 20.002(13) allows Tribes to also apply for these grants. Section 31.385(1m) allows public inland lake protection and rehabilitation district formed under ch. 33, Wis. Stats, to also apply.

We recommend that municipalities or lake districts name **a position** that is either an official or employee of the municipality/lake district. By naming a position instead of a specific person, a new resolution does not have to be submitted to the DNR with future grant applications or personnel changes. Contractors and consultants cannot be designated as an authorized representative. The resolution may not pass on grant responsibility to another group or organization.

RE: Discussion and Action on Preferred Option for Dam Replacement

Background: The last Mill Pond Dam related item on the agenda pertains to the direction to City Staff concerning the preferred option for dam replacement (pending Common Council approval of a resolution indicating replacement in Item 6A). In October 2023, Ayres Associates (Ayres)

concluded the Mullet River Dam Spillway Improvement and Dam Removal Feasibility Study. The Study outlined three dam replacement options along with estimated project costs (detailed to the right). Attachment 1 provides a summary of the advantages and disadvantages of the three available options.

Option 1: Crest Gate	\$2,550,000	
Option 2: Slide Gates	\$1,850,000	
Option 3: Split-Leaf Gates	\$1,950,000

After the open-house, City Staff met to develop the preferred recommendation for Common Council consideration. Ayres also participated in this meeting to answer questions from City Staff and to provide additional information, as needed. Following that discussion, City Staff advises the Common Council to proceed with 'Option 1: Crest Gate' for the following reasons:

- The Crest Gate facilitates ease of overall operations, notably in regulating the water elevation of the pond.
- It provides the optimal solution for debris clearance and can be fully opened during power outages or emergencies without the use of auxiliary power.
- With minimal moving parts, the Crest Gate necessitates limited future maintenance and associated costs for the gate itself.
 - Note The Crest Gate does require a building for hydraulics with dimensions approximately 10' x 12'. The exterior could be cream city brick (or another aesthetically pleasing material) to match the base of the arch.
- The Crest Gate width will be 34 feet wide which will have the largest waterfall effect for aesthetics out of all the 3 options.

The Crest Gate is recommended over "Option 3: Split-Leaf Gates" by City Staff for the following reasons.

- The Split-Leaf Gate consists of two 10-foot-wide gates separated by a concrete pier, making it more difficult to pass large debris.
- It contains more mechanical moving parts, which may necessitate additional maintenance in the future.
- Although the Split-Leaf Gate may facilitate an increased sediment release from the Mill Pond, upon further discussion, it was noted that the primary area of sediment control would be focused on the area immediately upstream of the gate.

- Note Even with a Split-Leaf Gate, pond dredging remains the preferred and most effective option for removing or reducing sediment buildup throughout the entire pond area.
- The Split-Leaf Gate offers a more limited waterfall effect for aesthetics than does the crest gate.

"Option 2: Slide Gates" was deemed the least preferred option by City Staff due to its higher likelihood of catching debris and its less intuitive water level control compared to the Crest Gate and Split Leaf Gate.

<u>Staff Recommendation:</u> Move to direct staff to proceed with Option 1: Crest Gate for dam replacement




Option 1: Hydraulically Operated Crest Gate





RE: Approval of Maintenance and Operation Agreement for the Sugar Shack at City

Park with Plymouth Maple Association

<u>Background:</u> City Park has an abundance of Sugar Maple trees that provide natural beauty and shade to the Park. Pure maple syrup is made by concentrating the slightly sweet sap of the Sugar Maple tree. The process starts with drilling a tap hole into a maple tree. A spout is inserted to direct the sap to either a bucket or into tubing that sends the sap to a large collection tank. After harvesting in the trees, the sap is transported to a Sugar Shack where it boils down to become maple syrup.

At the Committee of the Whole meeting on March 23, 2023 Alder Nelson presented a concept of building a Sugar Shack in City Park to provide a permanent location for maple syrup production as part of the annual Maple Festival and also to provide a location for educational demos for children and adults. The direction from the Committee was to move forward with the project. A non-profit named Plymouth Maple Association was created to lead the project.

At the Common Council meeting on November 28, 2023 the Common Council accepted the design and location of Sugar Shack Structure in City Park subject to finalization of a maintenance and operations agreement between the City and the Plymouth Maple Association. Also, at the meeting February 1, 2024 the Plan Commission recommended the design of the Sugar Shack as presented.


A License Agreement for Sugar Shack at City Park prepared by Attorney Fieber between the City of Plymouth and the Plymouth Maple Association will be distributed at the meeting which outlines that the construction responsibility and future maintenance are the responsibility of the Plymouth Maple Association, but that the ownership of structure once complete will be that of the City. The agreement also outlines cancellation provisions, insurance requirements during construction and public events, and access to the facility.



RE: Amendment to City Ordinance, Section 10-1-51

Staff brought forth to the Committee of the Whole on December 12th, 2023, a proposed change to City Ordinance Section 10-1-51 – Parking of vehicles over 12,000 pounds or 16 feet restricted. Our recommendation was to change the length restriction from 16 feet to 22 ½ feet to allow for longer passenger vehicles to park overnight on city streets. Such longer vehicles having become common place in today's society.

The consensus of the Committee of the Whole was to move forward with the suggested change. Staff worked with the City's Attorney to draft the amended ordinance for Council's review and approval.

AN ORDINANCE AMENDING SECTION 10-1-51 OF THE MUNICIPAL CODE OF THE CITY OF PLYMOUTH, WISCONSIN REGARDING PARKING OF OVERSIZED VEHICLES

WHEREAS, pursuant to Wis. Stat. § 62.11(5) for the good order of the City and general safety and welfare of its residents the Common Council is authorized to enact general regulations; and

WHEREAS, the Chief of Police recommends modification to the City's current regulation regarding parking of oversized vehicles.

NOW, THEREFORE, the Common Council of the City of Plymouth, Wisconsin, does hereby ordain as follows:

Section 1. <u>Amending Code</u>. Section 10-1-51 related to parking of oversized vehicles is hereby amended to read as follows (deletions indicated by <u>strikethrough</u>; insertions by <u>underline</u>):

"Sec. 10-1-51 – Parking of vehicles over 12,000 pounds or 46 22 1/2 feet restricted.

- Street parking. No person owning or having control of any truck, (a) trailer, truck power unit, tractor, bus, or recreation vehicle with a tare or empty weight in excess of 12,000 pounds gross weight or over 46 22 1/2 feet (270 inches) in length (including accessories, racks, or other physical extensions) or having a height of more than eight feet from the roadway shall park the same upon any street, avenue, or public way in the City of Plymouth between the hours of 7:00 p.m. and 5:00 a.m. The provisions of this subsection shall not be deemed to prohibit the lawful parking of such equipment upon any street, avenue, or public way in the city for the actual loading or unloading of goods, ware, or merchandise provided the "loading" and "unloading," as used in this section, shall be limited to the actual time consumed in such operation. The common council may, however, designate specific truck parking zones.
- (b) Removal. Any vehicle unlawfully parked under subsection (a) above may be removed from the street by order of a law enforcement officer pursuant to section 10-1-32, and the expense of so moving and storing such vehicle shall be paid by the operator or owner of said vehicle as a forfeiture in addition to the penalties hereafter prescribed."

The ordinance change being presented to you for the council meeting on 2-13-2024 consists of the following:

- (b) Residential Fire Pit Construction. Residential recreational bonfire or fire pit areas may be constructed and used with the following conditions and subject to the permit requirement of subsection (d):
- (2) Ceremonial Non-residential campfire or bonfires;

Theses changes are being presented to the common council for a few reasons.

- In research and talks with surrounding communities, Plymouth is the only community in the area that requires
 a fire pit permit for residential fire pits. It is difficult to impossible to confirm this permit is being pulled for all
 residential fire pits.
- The ordinance change is only to remove the annual permit for residential fire permits. Residential fires must still meet safe distance and placement requirements. Any other types of burning would still need a permit and approval.

AN ORDINANCE AMENDING SECTION 5-2-9 OF THE MUNICIPAL CODE OF THE CITY OF PLYMOUTH, WISCONSIN REGARDING OPEN BURNING

WHEREAS, upon recommendation of the fire chief, the Common Council of the City of Plymouth finds it best serves the public interest to allow residential recreational fires without a permit when such fires are contained within fire pits constructed and used in conformity with City Code Section 5-2-9.

NOW, THEREFORE, the Common Council of the City of Plymouth, Wisconsin, does hereby ordain as follows:

Section 1. <u>Amending Code</u>. Section 5-2-9, Open Burning, of the City of Plymouth Code is hereby amended to read as follows (deletions shown by <u>strikethrough</u>, additions by <u>underscore</u>):

"SEC. 5-2-9 OPEN BURNING.

- (a) **Open Burning Prohibited**. No person, firm or corporation shall build any outdoor fire within the corporate limits of the City of Plymouth, except as set forth in Subsections (b) or (c) of this Section or as permitted under Subsection (d). Fire disposal of rubbish, trash, or combustible waste is prohibited.
- (b) **Residential Fire Pit Construction.** Residential recreational bonfire or fire pit areas may be constructed <u>and used</u> with the following conditions and subject to the permit requirement of subsection (d):
 - (1) Permanent fire pits shall not be constructed within ten (10) feet of a structure or combustible material, unless otherwise approved by the Fire Chief.
 - (2) Permanent fire pits shall be no larger than forty (40) inches in diameter.
- (c) **Exceptions**. Outdoor cooking over a non-wood burning fire fueled by charcoal or propane gas contained in a device or structure designed for such use, provided such fire is constantly attended by a competent person until extinguished.
- (d) **Permit Required**. The following fires are subject to a permit granted by the Fire Chief:

- (1) Controlled burning of grass or similar vegetation for environmental management purposes;
- (2) Ceremonial Non-residential campfire or bonfires;
- (3) Other occasions of desirable outdoor burning not specified by this Subsection but not as an alternative to refuse removal or disposal of which other methods are available may be granted single occasion approval.
- (4) The permit shall be granted only after an on-site inspection, consideration of any hazards that could affect adjacent property and observance of any safety restrictions that the Fire Chief may require. All open or recreational fires must be constantly maintained by a competent person until extinguished. A fee of Five Dollars (\$5.00) shall be paid to the City of Plymouth for each permit issued.
- (e) **Chief May Prohibit**. The Fire Chief is permitted to prohibit any or all bonfires and outdoor rubbish fires when atmospheric conditions or local circumstances make such fires hazardous except on written permit from the Fire Chief or any fire warden for said City, which permit shall designate the time and place for such burning. Notice of designation of a fire danger emergency period shall be made by publication of an appropriate order, once in the official newspaper, to be effective forthwith.
- (f) **Burning on Streets**. No materials may be burned upon any street, curb, gutter, or sidewalk.
- (g) **Liability**. Persons utilizing and maintaining an outdoor fire shall be responsible for any liability resulting from damage caused by the fire.
- (h) Airborne Open Flame Devices Prohibited. No airborne open flame device may be launched or used, free-floating or tethered, in the City. Airborne open flame devices from neighboring jurisdictions that enter into the City are also prohibited. The term "airborne open flame device" means any airborne device typically constructed from paper with a wood frame containing a candle or fuel cell composed of a waxy flammable material or other open flame which serves as a heat source to heat the air inside the lantern to cause it to lift into the air. "Airborne open flame device" includes, but is not limited to, sky lanterns, sky candles, fire balloons, and airborne paper lanterns excluding manned hot air balloons."

Section 2. <u>Severability</u>. Should any portion of this Ordinance or the affected Municipal Code Section be declared unconstitutional or invalid by a court of competent jurisdiction, the remainder shall not be affected.
