Sealed bids, for the City of Plymouth "2024 Street Program" Contract, will be received by the **City Clerk, City Hall, 128 Smith St. - P.O. Box 107, Plymouth, WI 53073, until March 6, 2024, at 11:00 am, local time. Bids are required to be submitted electronically through [www.QuestCDN.com](http://www.QuestCDN.com).** Bids will be publicly opened and read aloud at the above time at the office of the City Clerk.

The work includes furnishing of all materials and equipment and performance of the following work, per the Plans, Specifications and Contract Documents (PS & CD).

The project is located on Forest Avenue between Milwaukee Street and North Street. A brief description of the major work items for the above contract includes:

2,500 cubic yards of common excavation, 3,400 tons of crushed aggregate base course, 1,520 linear feet of PVC watermain, 665 linear feet of 1-inch water service, 1,337 linear feet of 8-inch sanitary sewer, 6 sanitary sewer structures, 65 linear feet of storm sewer, 3 storm sewer structures, 3,000 linear feet of curb and gutter, 1,050 tons of HMA pavement.
