Recently one owner bought out the other 2 owners. Part of the requirements for the revolving loan fund is to haver personal guarantees. Plymouth Fish Springs is asking to release the 2 owners. In exchange for the release of the 2 personal guarantees the borrower is willing to pledge a fillet machine as collateral for the loan.
