- 2 – New squad cars are being equipped but supply chain issues have delayed delivery.

- 4 – Body camera issues have occurred with the old and outdated body cameras. Police Department are in the trial with Motorola body cameras. The department is obtaining pricing. New cameras have been approved in the budget.
- 5 – Plymouth Police officers, Lt. Primising and Lt. Thom completed three weeks in Leadership Police Organizations.

Plymouth Fire Department report by Fire Chief Ryan Pafford:

- 1 - Critical skills training is continuing.

2 – Sheboygan County Fair staffing is being prepared.

3 – Ryan brought to the committee's attention three recent new Plymouth Fire Department members who may not have fully complied with Plymouth police and Fire Commission By-Laws approved during December 2023.
