Schedule Smg-1: General Sewage Service - Metered

Available to sewage customers discharging domestic strength sewage up to 200 milligrams per liter of B.O.D., 175 milligrams per liter of suspended solids, and 7 milligrams per liter of phosphorus.

Available to high-strength sewage customers discharging waste that is stronger (over 200 mg/l of B.O.D., 175 mg/l of suspended solids and 7 mg/l of phosphorus) than domestic sewage.

<u>Schedule Sum-1: General Sewage Service – Unmetered CLOSED TO NEW CUSTOMERS (Customer may install approved meter on private well)</u>

Available to single-family and small commercial customers discharging only domestic strength sewage who temporarily are taking water service on an unmetered basis or who have their own wells, with the permission of the utility. This rate approximates the cost of 700 cubic feet per month discharged under Schedule Smg-1. If it is determined by the utility that the user discharges more than 700 cubic feet per month, an additional charge of \$3.66 per 100 cubic feet will be made for estimated additional usage.

Schedule Am-1: Additional Meter Rental Charge

Available to customers as a sewage deduct meter to receive credit for water not discharged into the sanitary sewer, or as a sewage meter for those who are not customers of the water utility. The minimum rental period shall be one year.

RIGHT OF ACCESS TO METERS

The utility has the right to access to the customer's premises at all reasonable times for the purpose of installing, reading, inspecting, repairing or removing any meter, device or other equipment used in connection with providing electric, water or sewage service.

TERMS OF PAYMENT

The bill for electric, water or sewage service constitutes the sum of any fixed charge, plus billing for amount used or minimum billing. Payments are due on the date specified on the bill. The customer may be given a written disconnect notice for a past due bill 20 days after the bill is issued and unless payment or satisfactory arrangement for payment is made within the next 8 days, service may be disconnected pursuant to Chapter PSC 113 and 185 of the Wis. Adm. Code.

If service is disconnected for non-payment of bill, a reconnection charge will be added to the service billing. When deferred payment arrangements are requested, such must be in written form. Verbal arrangements are not acceptable.

Late Payment Charge: A charge of one percent per month will be added to bills not paid

within 20 days from date of issuance.

If payment is made by check and the check is returned by the financial institution marked: "NO ACCOUNT, ACCOUNT CLOSED, or INSUFFICIENT FUNDS", an additional charge of \$25.00 will be added to the service billing.
